ELIGIBILITY CRITERIA FOR ADMISSION TO XI (COMMERCE)

A minimum of 55% marks in aggregate in all five main subjects in class X examination.

Note: Students who have passed Mathematics-Basic(241) at Secondary level are not eligible to opt for Mathematics in Sr. Secondary level (Class-XI).

Important Instructions to Note:

- (1) It is mandatory for all Parents / Students to fill-up the option form and send by e-mail to (kv2crpfadmission@gmail.com) within the scheduled date.
- (2) Option Form is available in Vidyalaya Website.
- (3) Documents desired to be verified at the time of admission.
 - (i) Downloaded mark sheet from CBSE website.
 - (ii) Photo copy of Caste Certificate by the name of the Student if he/she belongs to SC / ST/OBC.
 - (iii) Divyang (PH) Certificate by the name of the Student if he/she belongs to Divyang(PH).
- (4) Duly signed option form both by students and parents.
- (5) Concession of Marks will be given only on submission of photocopies of supporting documents. The original certificate is to be produced at the time of admission for verification. No concession / relaxation will be allowed without supporting documents.
- (6) Incomplete Option Forms will be rejected and no request shall be entertained thereafter.
- (7)(A) The following concession will be granted to students for admission who participated in Games & Sports meet/Scouting & Guiding/NCC/Adventure activities at various levels. The certificate needed for this purpose can be of any of the preceding years.

(8) (B) Students belonging to SC/ST/OBC/ Divyang (PH) would be given up-gradation in aggregate by 4% Marks for the purpose of admission to class XI.

(9) All the documents submitted must be self-attested by the parents.

Note: Maximum concession under Sports/Games/NCC/Scout/Guide/Adventure will not exceed 6% Marks in aggregate. In case of eligibility for more than one concession under different categories as mentioned at (A) and (B) above, only one concession having maximum advantage to the candidate will be allowed. (The same benefit may be extended to non-KV Students for fresh admission in KVs.)
