For the Session 2021-22 (for the students of KV NO-2, CRPF: science and commerce and other neighbouring KVs: Commerce only)

With reference to the KVS Admission Guidelines-2021-22, admission to science and commerce stream of Class XI is to be done after declaration of Class: X CBSE result. All the students and parents of K.V No-2, CRPF, Bhubaneswar are requested to submit the duly filled **Option Form** and supporting documents (downloaded marksheet (DigiLocker), caste certificate etc.) physically in the Vidyalaya in accordance with SOP of the Covid-19 guidelines. Option Form is available in the Vidyalaya Website (no2bhubaneswar.kvs.ac.in) and it is also being sent to you in your previous (Class X WhatsApp group). The students of other neighbouring KVs in which commerce is not available can also apply by filling registration form along with option forms and submit the same in the Vidyalaya. You are requested to submit the documents as per the schedule mentioned below.

ELIGIBILITY CRITERIA FOR ADMISSION TO XI (SCIENCE AND COMMERCE)

FOR KV Students:

Admission in different streams viz Science and Commerce of Class XI for KV students will be based on aggregate marks of main five subjects scored in class X exams as under: -

(1). Science Stream

(i) A minimum of 60% marks in aggregate of all subjects. (subject to availability of class limit)

(2). Commerce Stream

(i) A minimum of 55% marks in aggregate of all subjects. (subject to availability of class limit)

Important Instructions to Note:

(1) **It is mandatory for all Parents / Students to fill-up the option form and submit in the Vidyalaya within the scheduled time, otherwise it will be considered that they are unwilling to take admission in KV No.2, CRPF, Bhubaneswar.**

(2) Option Form will be available in the Vidyalaya Website and also it is sent in the WhatsApp Group. Candidates willing to apply for both science and commerce must apply in separate option forms.

(3) **Original Documents desired to be verified at the time of admission.**

(i) Downloaded mark sheet from CBSE website (DigiLocker).

(ii) Photo copy of Caste Certificate by the name of the Student if he/she belongs to SC / ST/OBC (wherever applicable).

(iii) Divyang (PH) Certificate by the name of the Students (wherever applicable).

(4) Duly signed option form both by students and parents.

(5) Concession of Marks will be given only on submission of photocopies of supporting documents. The original certificate is to be produced at the time of admission for verification. No concession / relaxation will be allowed without supporting documents.

(6) Incomplete Option Forms will be rejected and no request shall be entertained.

(7) The following concession will be granted to students for admission who participated in Games & Sports meet/Scouting & Guiding/NCC/Adventure activities at various levels. The certificate needed for this purpose can be of any of the preceding years.



(8) Students belonging to SC / ST/ Divyang (PH) would be given up-gradation in aggregate by 4% for the purpose of admission to class XI Science / Commerce Stream.


(9) **NOTE:** Maximum concession under Sports/Games/NCC / Scout / Guide/Adventure will not be exceeded 6% in aggregate. In case of eligibility for more than one concession under different categories as mentioned at (Point 7) and (Point 8) above, only one concession having maximum advantage to the candidate will be allowed.

(10) All the documents submitted must be self-attested by the candidate and parents.

*The above mentioned admission rules/criteria are as per KVS Admission Guidelines 2021- 22, these may be changed by KVS at any time and all these amendments issued by KVS in future (if any) will be automatically applied.
